- [Minnesota Peacetime Emergency Childcare Grant Application](#): Grant amounts will vary between \$4,500 and \$21,000/month; and will be distributed in April, May and June as funding is available or until the peacetime emergency has ended. - [Child Care Assistance Program Waivers-Provider Memo](#): This memo provides information for child care providers about temporary policy modifications, along with reminders of existing policies.
- [Minnesota Unemployment Insurance](#): Minnesota is one of the first states in the nation to implement both the \$600 per week additional compensation and the 13 week extension of benefits (PEUC) available under the Coronavirus Aid, Relief, and Economic Security Act (CARES).
- The Minnesota Department of Education will ensure children and programs who receive early learning scholarships will continue being served and funded.
 - ✓ Absent days will not be counted towards the 25 maximum absent days policy in order for families to make individual decisions that are best for their families.
 - ✓ Programs that temporarily close due to response to COVID-19 mitigation, regardless of program type, will have closure days waived for the duration of the crisis.
 - ✓ As funds allow, a child's scholarship temporarily may be increased if the program regularly attended closes, and the child attends another eligible program as back-up.

Federal Resources

- Child care providers may also be eligible for business loans, including the [Federal Small Business Administration COVID 19 Disaster Loans](#).
- The federal Coronavirus Aid, Response and Economic Security (CARES) Act has provisions that expand
 - ✓ The [Small Business Administration's Economic Injury Disaster Loans](#) (allows a \$10k grant upfront regardless if you take a loan – apply at [SBA.gov/disaster](https://sba.gov/disaster))
 - ✓ The new [Paycheck Protection Program](#) (with certain conditions can be forgiven; apply directly through participating lenders), for which providers may be eligible.
